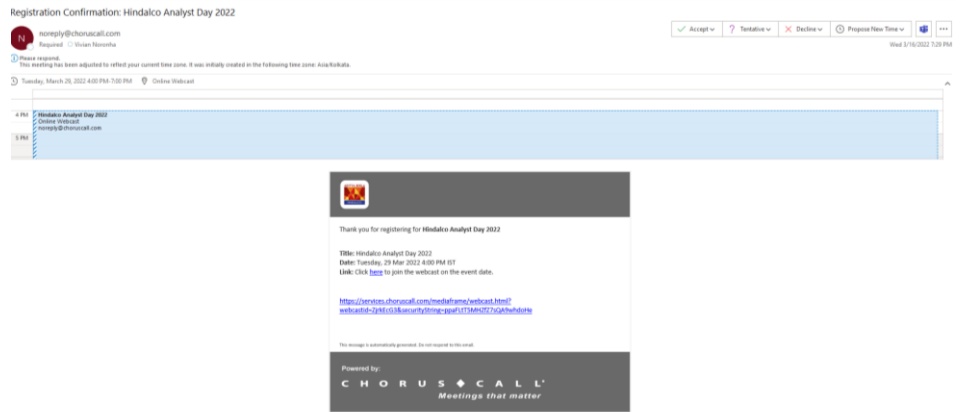

## Q&A Instructions

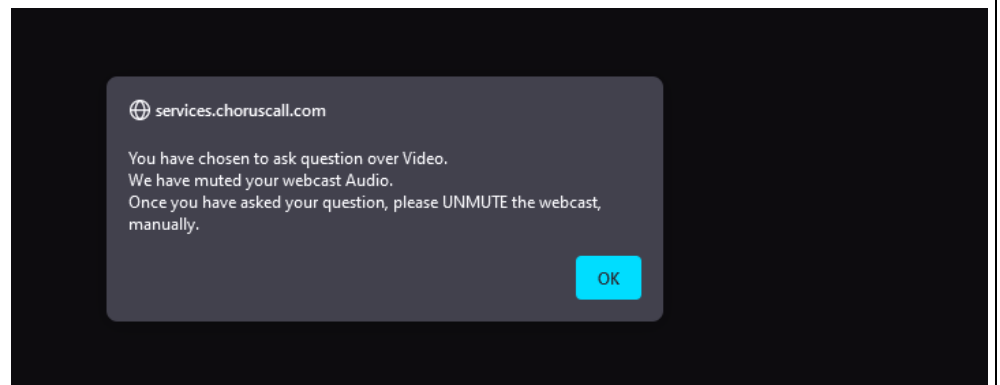
You can ask questions via audio by clicking on the Audio Question button. You will receive a list of dial in numbers to join the event via Audio.

## Browser Auto Pop up

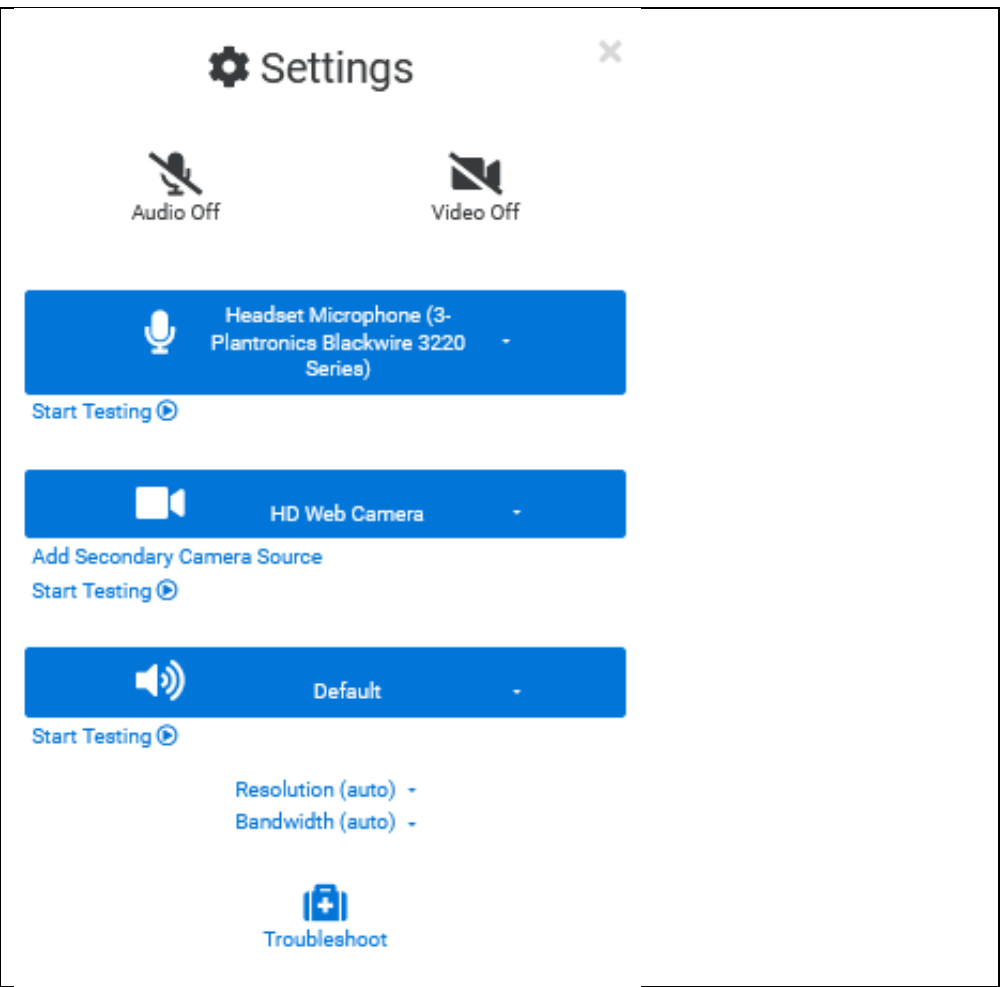
Please note, once the question tabs are clicked on, please click on 'OK' to proceed with live question.
